

**The Third Annual FCAT-Towaoc  
Spirit of Christmas  
Invitational Swim Meet  
December 19-21, 2008  
Towaoc, CO**

- SPONSOR:** Four Corners Aquatic Teams
- SANCTION:** Held under sanction of USA Swimming, Inc. and Colorado Swimming, Inc. Sanction # 2008-082
- DISCLAIMER:** USA Swimming, Inc., Colorado Swimming, Inc., the Ute Mountain Ute Tribe, and all meet officials shall be held free from liabilities or claims for damages arising by reason of injuries to anyone during the conduct of this meet.
- VENUE:** The Spirit of Christmas Swim Meet will be held on the Ute Mountain Ute Tribe Indian Reservation in Towaoc, CO. Competition will take place in the Recreation Center Indoor 25M 6 Lane Pool. There are separate male and female locker rooms with rest room facilities. The adjacent Ute Mountain Gymnasium will be used as a spectator and bullpen area. Closed circuit television of all races will be provided. Free parking will be available.

- TIMING:** A Colorado Timing and Scoring System will be used.
- DIRECTIONS:** The Ute Mountain Ute Tribe Indian Reservation is easily located. Towaoc, the southwestern-most town in the state of Colorado, rests on Hwy. 160 approximately 15 miles due south of Cortez. Simply turn by the Ute Mountain Travel Center and drive up the hill. The Recreation Center parking lot is on the left immediately after negotiating a small s-curve around the Tribal Complex.
- ELIGIBILITY:** Competitors must be 2008 or 2009 USA Swimming registered. All swimmers registered with USA Swimming are eligible to compete. Swimmers are restricted to **FIVE (5)** individual events and **ONE (1)** relay per day. Swimmers may swim in only one age group per event. 8 & Unders may swim and score points in 10 & Under events if the event is not offered in their age group. The swimmer's age as of December 19, 2008 shall be used to determine the age

group for competition. It is a violation of USA Swimming rules to enter an unregistered swimmer and such an entry could result in a fine.

Swimmers on the CSI exceptions report must be prepared to show their card, or they will be deck registered before they can enter the water. A surcharge for deck registration will also apply, \$27 for year round, \$14 for seasonal, plus the normal registration fee. Coaches will be asked to display current USA Swimming registration cards. **USA SWIMMING MEMBERSHIP AFFIDAVIT MUST BE SIGNED AND RETURNED ALONG WITH ENTRIES.**

**ENTRIES:** Please submit all entries on the entry forms attached. One form is required for each participating swimmer. If a HY-TEK entry disk is used, please include a hard copy of the entries. HY-TEK entries on disk or email are strongly urged. Email entries to: pdumont@utemountain.org.

**ENTRY FEES:**

Individual events:	\$3.00 per event (includes Colorado Swimming \$.50 surcharge)
Relays:	\$5.00 per relay
Pool Usage Fee:	\$5.00 per swimmer

Charge for Non-Hytek entries = \$30 (for teams of 10 or more swimmers).

Relays may be deck entered, but must be paid for by the end of Session V in order to receive awards.

**DECK ENTRIES:** \$5.00 per individual event. Deck entries will be accepted only where lanes are available. New heats will not be created for deck entries. Deck entries must be completed 30 minutes prior to the start of each session. Anyone deck entering that is not already entered in the meet must show proof of current USA Swimming registration. **LATE ENTRIES MUST BE PAID FOR AT TIME OF ENTRY.**

**ENTRY DEADLINE:** Swimmer entry forms, email entries, or HY-TEK disk with printed hard copy, Membership Affidavit and entry fees must be received by **December 15, 2008**. Please make team checks payable to the Ute Mountain Ute Tribe. Entries are limited to the first **350** swimmers. Please call or email to confirm receipt of entries. **WARM-UP:** CSI mandatory warm-up procedure will be in effect throughout warm-up times. All swimmers must be supervised by a coach member of USA Swimming during all warm-up sessions.

**SCORING & AWARDS:** Awards will be given as follows:  
Individual events: 1 – 12  
Relays: 1 – 6  
Individual and Runner-up  
High Point: \*1 + 2  
Team: winner only

Awards will be given in the following age groups: Open, 13 & 14, 11 & 12, 9 & 10, and 8 & Under.

\*As a special feature, this year's High Point and Runner-up High Point awards in all age-groups will be authentic and unique pieces of Ute Mountain pottery.

**RULES:** 2008 USA Swimming and CSI rules will govern this meet.

**RESTRICTIONS:** FCAT-Towaoc and the Ute Mountain Ute Tribe prohibits smoking or use of other tobacco products on the pool deck, in the changing rooms, in spectator seating and in all areas used by swimmers during the course of this meet, including the gymnasium. No glass containers will be allowed anywhere inside the Ute Mountain Recreation Center Pool.

**CONCESSIONS:** Concessions will be available throughout the meet.
