

Colorado Springs Swim Team 2010 Spring Open

April 16-17, 2010

- Location: Colorado College
14 Cache La Poudre
Colorado Springs, Colorado
- Sanction: Held under the sanction of USA Swimming: **Sanction Number: 2010-043**
- Facility: Indoor eight lane 25 yard pool. Depending on the number of entrants, individual sessions may swim using 7 lanes with one lane for continuous warm-up. The competition course has not been certified in accordance with USA Swimming regulation 104.2.2C (4).
- Timing: Colorado Timing System with display board.
- Rules: Current USA Swimming rules will govern the meet. The Meet Referee will be the final meet authority for the conduct of the meet.
- Eligibility: Open to USA Swimming registered athletes holding 2010 membership cards. Age as of April 16, 2010 will determine swimmer's age for the meet.
- Entries: Submit entries on a CSI ENTRY FORM OR A 3.5 INCH DISK FOR HY.TEC complete with all required information (name, USA number, entry time, age, and event number). Entries can also be submitted by e-mail using Hy-Tek comlink file. (Teams **not submitting** entries on a disk or via e-mail will be assessed a \$10.00 fee per team.) The meet will be limited to 300 individual entries in each session. The meet will be pre-seeded, except for the 500 yard freestyle and 400 yard IM which will require positive check-in. Swimmers in the 500 yard freestyle must check in by 5:30 PM on Friday and swimmers in the 400 yard IM must check in by 10:00 AM on Saturday. Swimmers in the 500 free will need to provide their own counters and timers (2 timers required). Swimmers in the 400 IM will need to provide their own timers. Entries must also be accompanied by the CSI meet verification form (USA swimmer registration verification).
- Qualifying Times: No qualifying standards for this meet EXCEPT FOR THE 500 FREESTYLE. CSST will limit the number of 500 freestyle entrants if we think the total number of swimmers is excessive.
- CSI Exceptions Report: Any CSI/USA Swimming registration errors must be corrected by Monday, April 5th with Kate Doane, Entry Chair. Teams will be notified via e-mail regarding registration errors. Swimmers who have not cleared registration exception problems prior to the start of the meet must re-register with USA/CSI swimming prior to the beginning of the meet.
- Events: Swimmers may enter five (5) individual events per day.
- Entry Fees: Individual events: \$3.60 per event (.60 per event to CSI support fund and .05 to MSL support fund).
- Surcharge: \$4.00 per swimmer.
- Deck entries: \$5.00 per event if lanes are available. The Meet Director reserves the right to deny a request for a deck entry if such entry would result in adding heats to existing events.

One *CHECK PER TEAM PAYABLE TO CSST*. Officials working both sessions will have one swimmer's entry fees refunded less the .50 CSI fee per event and the \$4.00 surcharge.

Awards: **High Point Awards 1st-6th place for: 8 & Under/9-10/11-12/13-14/15 & Over**

Scoring: Team scores will not be kept.

Officials: Teams participating in this meet are encouraged to provide on deck officials. Officials working in both meet sessions will be eligible for a refund of one swimmer's entry fees (less the pool surcharge and CSI support fund amounts).

Warm-up Procedures: Standard CSI warm-up procedures will be in force for this meet. Note that, in accordance with CSI regulations, all swimmers must enter warm-up lanes using a 3-point feet-first entry where both feet and one hand must be in contact with the deck or end wall immediately prior to entering the water. Swimmers entering the water during warm-ups will be observed and, if found to be in non-compliance with this ruling, the swimmer and/or their coach will be notified and warned of this violation of safety rules. Repetitive violations of this safety rule, if deemed by the Meet Referee to be willful or deliberately defiant, may result in the removal of the swimmer from competition for the remainder of the session.
